### Entry Fee

**\$25.00** per entry per dog trial

Closing date is Saturday, May 18, 2024. Incomplete, unsigned, or conditional entries will not be accepted. Entries accepted only online at <https://www.sugarloafmountainracing.com> and no other methods of entry will be permitted. Online entries will have an additional \$0.50 processing fee added per entry. **Mailed paper entries with checks will be rejected and destroyed.**

### Conditions of Entry

Entries will be limited to 50 dogs per trial, two trials running concurrently 12:00-2:00PM, or immediately following the Fast CAT events, whichever is later. **The run order is based on order of entries received. All refunds are subject to a \$3.00 administrative fee per entry. No refunds after the closing date. Dogs will run in the order of entries received.**

This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Bitches in season may be tested as the last dogs at the end of the day. If there are two events on one day, **a bitch in season may only be tested as the last dog in the event.** A bitch in season may return if there are events on a second day, and again, be tested as the last dog of the event at the end of the day. **Bitches in season should not be waiting in the area with other dogs.**

### Condition of the Dog

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the Fetch test. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs are allowed to enter so long as the handler is always in control of the dog, the dog can complete the requirements of the test, and the dog does not appear to be under undue stress in the opinion of the judge.

A maximum of 10 entries per day shall be placed on the wait list. If a withdrawn entry is replaced by a waitlisted entry, a refund will be issued for the withdrawn entry.

Move-ups to the next higher level will be offered. Move-ups shall notify the event chair, secretary, and confirm with the judge, before the test begins.

### **Course Elimination**

Dogs who urinate or defecate on the AKC Fetch test course shall be immediately excused by the judge and asked to leave the test area with a non-qualifying score.

## Trial Site Directions

From Washington DC and East: Take I-66 West towards Front Royal, take Exit 23 US-17 North, and continue and turn left on US-50 West. Turn left onto US-340 South for 2 miles, turn left onto SR-658 White Post Road, and the site will be on the right.

From Hagerstown and North: Take I-81 South towards Roanoke, take Exit 313A US-50 East for 7 miles, turn right onto US-340 South for 2 miles, turn left onto SR-658 White Post Road, and the site will be on the right.

From Richmond and South: Take I-95 North towards Washington DC, take Exit 133 US-17 North, and continue and turn left on US-50 West. Turn left onto US-340 South for 2 miles, turn left onto SR-658 White Post Road, and the site will be on the right.

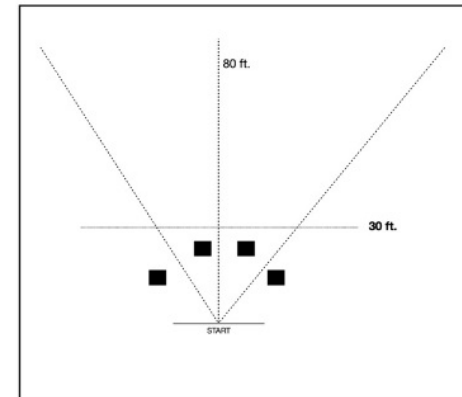
Overnight RV dry camping will be permitted on site, \$20 per evening.

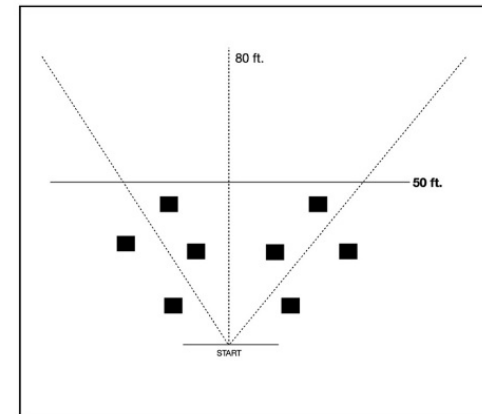

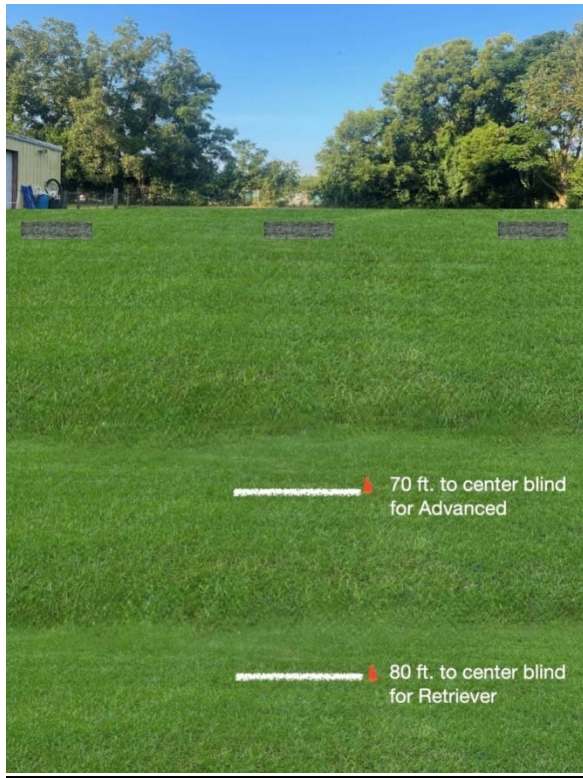
## Fetch Course Setup

### **Notice to Exhibitors**

#### *SAFETY, BEHAVIOR and LIABILITY*

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all requirements safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such a case, no refund of any fees paid will be made. The American Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club or any official thereof.

#### *COLLARS, LEASHES and HARNESSSES*

Dogs must wear a properly fitted collar approved by the judge. Leashes may be of any length, but not retractable. The leash should be made of plain, pliable material. Dogs may not wear prong collars, e-collars, head collars, muzzles, or body harnesses.

All dogs must be always on leash, and retractable leashes may not be used when on trial grounds. Dogs must enter and exit the trial area with the leash attached to the collar, including when waiting in the trial area before and after the trial.

#### *REFUNDS*

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. **Dogs pulled after closing because of injury or other medical condition are eligible for a refund with a signed veterinarian note.**

#### *RINGSIDE*

Judges are not required to wait for dogs. The owner of each dog is solely responsible to be ready when judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

Exhibitors MUST check-in EACH day they are entered.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event online at [SugarloafMountainRacing.com](http://SugarloafMountainRacing.com) web site.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
